



## Basic Warranty Overview

All of our exhaust systems are warranted against defects in material and/or workmanship for a period as stated below. This does not cover finishes such as plating, or painted surfaces with discoloration or rust. This warranty shall be limited to the repair or replacement of the system, which may be proven defective under normal use. We will not warranty any system that has been abused, misused, improperly installed, or modified.

Dealers or distributors are not authorized to make dispositions binding upon Straightline Performance. We will not be responsible for any labor charges incurred in removing or replacing any system under warranty.

**Lifetime Limited Warranty** applies to Straightline Performance stainless steel mufflers, stainless steel exhaust systems, stainless steel pipes and other stainless steel exhaust accessories (except exhaust tips).

**Two (2) Year Limited Warranty** applies to Straightline Performance aluminum / steel mufflers, aluminized steel exhaust systems, aluminized steel pipes, exhaust tips and other non-race exhaust accessories.

**One (1) Year Limited Warranty** applies to Straightline Performance steel / ceramic coated exhaust and extends the following limited warranty to the original purchaser of its mufflers, exhaust systems, pipes, exhaust tips, headers and other non-race accessories (hereafter "products")

Applies to all Straightline Performance electrical items, no electrical item can be returned, electrical items can only be repaired or replaced during the limited 1yr warranty.

Applies to all Straightline Performance non exhaust products, to include; tools, clutch components, drivetrain products, chassis components, and all other items.

**No Warranty Products** applies to all Straightline Performance products or products that have been used in a race application. This "non warranty" applies to all Straightline Performance products used in any race application, to include testing, non-sanctioned racing, and products for marketing, or free/marketing product.

Straightline Performance warrants the products mentioned above against defects in materials and workmanship for the period set forth below, when they are owned by the original purchaser and remain installed on the vehicle on which they were originally installed. This warranty is void if the product was not installed properly on the vehicle, was installed on a vehicle for which it was not designed, or was removed from the vehicle on which it was originally installed and reinstalled on another vehicle. This warranty shall not apply to normal wear, cosmetic issues such as coatings and material discoloration, any product that was installed on a racing vehicle, installed improperly or contrary to Straightline Performance instructions, altered, misused, repaired, damaged from an accident, collision, impacts or debris, or willful or negligent act.

To make any claim under the terms of this limited warranty, the original purchaser **MUST** either return the product to the original retailer or directly to Straightline Performance. If the original purchaser elects to return the product to Straightline Performance directly, he or she must first contact Straightline Performance and obtain a Returned Material Authorization (RMA) number. Once the RMA number is received, the original purchaser may **return the product to Straightline Performance @ 15250 Hornsby St NE Forest Lake, MN 55025** (or such other address provided by Straightline Performance) along with the **RMA number and Proof of Purchase** of the covered product. The Proof of Purchase must clearly show the place of purchase, purchase price; product purchased, and date of purchase. If upon inspection by Straightline Performance the product is found to be defective in material or workmanship, Straightline Performance shall at its option, either repair or exchange the product for new product with the same part number or superseded part number.

The warranties set forth herein are exclusive and unless otherwise required by applicable law no other warranties are made by Straightline Performance or are authorized to be made with respect to the product
